The 2022 Permobil Canadian Apple Watch Sweepstakes (the "Sweepstakes")

Official Rules (Canada)

NO PURCHASE OR CONSIDERATION NECESSARY TO ENTER OR WIN. A PURCHASE OR CONSIDERATION DOES NOT IMPROVE YOUR CHANCES OF WINNING.

1. DATES OF SWEEPSTAKES

Sweepstakes begins at 12:00:01am Central Time ("CT") on April 7, 2022 and ends at 11:59:59pm CT on June 29, 2022 (the "Sweepstakes Period").

2. ELIGIBILITY

Sweepstakes is open only to legal residents Canada (excluding Quebec residents), who are eighteen (18) years of age or older as of the date of entry and who use a SmartDrive MX2+ (the "Entrant"). Officers, directors, managers, and employees of Permobil, Inc. (the "Sponsor"), and each of its respective parents, subsidiaries, affiliates and related companies and their respective advertising and promotion agencies, consultants and agents, as well as immediate family members and/or those living in the same household of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes (collectively the "Sweepstakes Entities") are not eligible to participate. The postcard must be postmarked during the Sweepstakes Period and received prior to the last random drawing, as described in Section 4 below.

Entrant is limited to one (1) entry per Entrant for the entire Sweepstakes Period, regardless of the entry method chosen. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, both methods, and/or any other methods will void that Entrant's entry and that Entrant may be disqualified from the Sweepstakes. 4. DRAWING/ODDS

Sponsor will not replace any lost or stolen prizes. In the case of unavailability of any prize, Sponsor reserves the right to substitute a prize of equal or greater value. Each prize winner is solely responsible for all applicable federal, provincial and local taxes, including taxes imposed on his/her income. No more than the stated number of prizes set forth in these Official Rules will be awarded.

Potential prize winners consent to the use of his/her name, likeness, biographical information, and voice in advertising worldwide without additional compensation.

7. NOTIFICATIONS/CLAIMS

Winners will be announced on the Sponsor's Twitter account (@PermobilCanada) and notified by email. Winners will be required sign and return a Liability/Publicity Release (collectively, the "Paperwork"). After Sponsor receives the completed Paperwork, Sponsor will mail each winner his or her prize to the address submitted by the winning Entrant when he or she entered the Sweepstakes. If the potential winner fails to return the Paperwork or is found to be ineligible, or if he/she does not comply with the Official Rules, such potential winner and his/her entry will be disqualified and another potential winner will be selected from the remaining eligible entries received.
